



COVID Assumption of Risk and Waiver of Liability Terms for the 2023 IIHF Championship Season ("TERMS")

PLEASE READ CAREFULLY BEFORE CHECKING THE BOX ON THE REGISTRATION PAGE

By registering for the respective 2023 IIHF Championship, I certify that (1) I have fully read and understand the below TERMS and agree that they apply to me; (2) **I understand that I am waiving important legal rights to recover damages for injury and/or property damage;** (3) I have read and voluntarily accept the TERMS; and (4) no oral representations, statements or inducements apart from such agreed to in the TERMS have been made.

The novel coronavirus, also known as COVID-19, and variants/mutations of the virus that causes COVID-19 (collectively below, "COVID-19") can be extremely contagious and is believed to spread mainly from person-to-person contact. Contracting COVID-19 can lead to severe illness, personal injury, permanent disability, death, or may lead to short or long-term effects that impair or prevent the Participant from pursuing his/her professional career. The International Ice Hockey Federation ("IIHF") and the relevant Organizing Committee ("OC") are undertaking efforts to keep the respective IIHF Championship facilities clean and disinfected, and – when necessary – have created COVID-19 Rules/Regulations/Protocols and preventive measures to reduce the spread of COVID-19. However, the IIHF and OC cannot guarantee that you will be safe from COVID-19 while participating in the respective IIHF Championship, either while traveling to or while in the venues of the respective 2023 IIHF Championship.

By registering for this 2023 IIHF Championship and attending the respective 2023 IIHF Championship, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to, or infected with COVID-19 while traveling to or participating in the respective 2023 IIHF Championship, and that such exposure or infection may result in personal injury, illness, permanent disability, death or may lead to short or long-term effects that impair or prevent me from pursuing my professional career. I understand that the risk of becoming exposed to or infected with COVID-19 during the respective 2023 IIHF Championship may result from the actions, omissions, or negligence of myself and/or the negligence of others, including, but not limited to, the IIHF or OC and/or other 2023 IIHF Championship participants, and their respective officers, employees, volunteers, representatives and players.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any COVID related injury to myself including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation in the respective 2023 IIHF Championship. On my behalf, I hereby release, agree not to sue, discharge, defend, indemnify and hold harmless, the IIHF and OC, and their respective officers, employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after my participation in the respective 2023 IIHF Championship.

I voluntarily agree to comply with all IIHF COVID-19 Rules/Regulations/ Protocols for the respective 2023 IIHF Championship, which I acknowledge can be amended or updated at any time. I understand and agree that if I do not follow IIHF and/or OC COVID-19



Rules/Regulations/Protocols that may be put into place from time to time, I may be expelled from the respective 2023 IIHF Championship.

I acknowledge and agree that the terms and condition listed herein are governed by Swiss Law, and that all provisions contained herein are also valid under my MNA's national law and/or the law of my place of residence.
